Statement

This document outlines an agreement between GRRCC and the Community Artist. This agreement will detail the roles and responsibilities of both parties.

GRRCC is pleased to offer space within the J. Wesley Graham Patient & Family Resource Centre to display art from artists within our community. We envision the "Community Artist Exhibit Wall" as a vibrant, evolving space that allows us to represent our community in new ways.

Agreement

1. Artist Exhibit Applications

- **a.** Any Community Artist interested in applying to be featured at GRRCC will complete the "Community Artist Wall Application Form" (<u>Microsoft Forms Link</u>). Completed applications will be reviewed by the JWGRC Working Group.
- **b.** GRRCC reserves the right to decline any applications that are not suitable for a hospital environment or that do not align with our community, patient population, mission or values.
- **c.** Exclusions: profanities, nudity, violence, sexual content, or displays that contravene federal/provincial or municipal laws.
- **d.** Preference will be given to local Community Artists that live and work within the catchment area for GRRCC (Waterloo Wellington), and who have not yet had the

- opportunity to display their work. However, we will accept applications from all Community Artists as well as repeat applications.
- **e.** Community Artists will be accepted on a first come first serve basis, and will have the opportunity to exhibit their art according to the next available opportunity.
- **f.** Should a Community Artist request to defer their offered display term, then it will be offered to the next approved Community Artist.

2. Term

- **a.** The exhibit will have a display term of 4 months.
- **b.** Exhibits will be rotated 3 times a year.
- **c.** GRRCC does not pay exhibit fees or offer any insurance for displays.

3. Art Display & Installation

- **a.** Exhibit will be displayed in the J. Wesley Graham Patient & Family Resource Centre located on the main floor (3rd floor, J339) of the Grand River Regional Cancer Centre.
- **b.** Space provided will be on a 4ft wide x 5ft tall grid wall space (Gridwall Panels 2 x 5' H-6277 Uline)
- **c.** The Community Artist is responsible for providing the art pieces for their exhibit, ready to hang.
- **d.** Installation and/or hanging of the artwork will be completed by the Community Artist on the first day of the agreed upon display term.
- e. Art must be able to be hung by a gridline hook (Grid Picture Hook S-19939 Uline).
- **f.** The Community Artist is responsible for obtaining their own damage insurance for the contents of their exhibit.
- **g.** Maintenance of the exhibit wall will be completed, as needed, by GRH Maintenance department.
- **h.** GRRCC cleaning staff will be instructed not to clean the artwork or use any harsh chemicals or solvents on the art or frame.
- **i.** GRRCC reserves the right to alter, move, remove or cancel any exhibit that may be deemed in breach of this agreement or Grand River Hospital policy.

4. Disassembly

a. The Community Artist is responsible for take down and removal of the exhibit on the last day of their term.

5. Advertising & Social Media

- **a.** GRRCC does not allow solicitations, recruitment or business sales/fundraising for the exhibit.
- **b.** A flyer will be displayed with the Community Artist's bio, photo, contact information/social media handles. No information about pricing will be available at GRRCC; interested buyers will need to contact the Community Artist directly via social media.
- **c.** A social media post(s) will be created and shared on GRH socials advertising the new Community Artist exhibit.
